

## **Licence Notice**

## <u>Preface</u>

Whilst we encourage people to use the indices, the use is subject to certain conditions to ascertain consistency now and in the future between the various users. This agreement/license is meant to assure this.

## Licence

- 1. Airparif (Karine Léger), DCMR Environment Protection Agency Rijnmond (Sef van den Elshout), ATAC SpA Mobility Agency for the City of Rome (represented by Fabio Nussio) and Heich Consult (Hermann Heich) (hereinafter "Owners") are the exclusive owners of all intellectual property rights on the methodology of the air quality indices CAQI and YACAQI, the accompanying documentation, i.e. version "Component 3 Comparing Urban Air Quality Across Borders" and follow ups of the documentation (both hereafter referred to as "documentation"), a detailed description of the methodology of the air quality indices and means (e.g. excel sheets) to test the proper application of the indices (both referred to hereafter as "air quality indices package") and the corresponding common operational website (COW, <a href="https://www.airqualitynow.eu">www.airqualitynow.eu</a>). Any of the three is entitled to represent the three others.
- 2. The Owners offer the User to download the documentation and the air quality indices package from its website free of charge.
- 3. In order to enable the User to use the documentation and the air quality indices package for his own business purposes the Owners hereby grant to the User a nonexclusive, limited, non transferable, revocable, worldwide right to:
  - a) reproduce the documentation and air quality indices package for scientific purposes in electronic or non electronic form (e.g. displaying, storage, printout),
  - b) communicate the indices, i.e. the outcome after having applied the methodology, to the public in material or non-material form, provided that proper references to the source of the indices are made.
- 4. Other rights than those mentioned in section 3 are not granted to the User. It is hereby explicitly prohibited to reproduce the documentation and/or the air quality indices package for any other purposes as laid down in section 3 without the prior written consent of the Owners. Furthermore, without the prior written consent of the Owners, the User has neither the right to translate, adapt, arrange or alter the documentation and/or the air quality indices package in any other way nor the right to distribute the documentation, the air quality indices packages and/or the indices or copies thereof, including sale and rental. Furthermore, it is prohibited without the prior written consent of the Owners to authorize any communication to the public of the documentation, the air quality indices package and/or the indices by wire or with wireless means, including the making available to the public of the documentation, the air quality indices package and/or the indices in such a way that members of the

public may access the documentation, the air quality indices package and/or the indices from a place and at a time individually chosen by them.

- 5. The rights granted to the User under section 3 only apply to the latest version of the documentation or the air quality indices package. Any rights granted to the User concerning a previous version of the documentation or the air quality indices package will be automatically revoked as soon as a new version is available for download at the Owners website [www.airqualitynow.eu]. Registered Users will be informed of available updates of the documentation or the air quality indices package. Nevertheless, all Users are held to regularly check the Owners's website to ensure that only the latest version of the documentation and/or the air quality indices package are applied by the User.
- 6. Any usage of the documentation, the air quality indices package and/or the indices itself outside the scope of this licence constitutes an infringement of Owners intellectual property rights and is a material breach of this licence.
- 7. The Owners liability for all material damages arising out of the use or inability to use the documentation, the air quality indices package and/or the indices (including but not limited to loss of data or data being rendered inaccurate or losses sustained by the User or third parties or a failure of the air quality indices package to operate with a computer program) is excluded, provided that the damage was not the result of intent or gross negligence of the Owners. In the event of death, personal injury or damage to health, Owners shall be liable in accordance with the statutory provisions. Liability under statutory provisions on product liability shall remain unaffected. Otherwise, liability is excluded.
